

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to [www.sunshinenutritionwellness.com](http://www.sunshinenutritionwellness.com) and Sunshine Nutrition & Wellness and governs data collection and usage. ## Collection of your Personal Information

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through SN&W's public message boards, this information may be collected and used by others.
